Buying Tour Agreement

I, _____ hereafter referred to as “client” agree to contract with Grand Central Station Antiques for an antiques buying tour on the following terms:

The payment of a non-refundable signing fee of \$250.00. Payable on initiation of the agreement and non-refundable for any reason except the trip is canceled by GCSA.

A 15% commission on the purchase price of all items purchased.

A \$50 minimum wrapping, packing, loading, unloading, delivery/shipping, customs fees and documentation fee will be charged for all non-furniture items smaller than 1 cubic foot. All non-furniture items larger than 1 cubic foot will be charged at a \$50 per cubic foot rate.

12 x 12 x 12 = 1728 cubic inches equals 1 cubic foot - \$50
15 x 15 x 15 = 3375 cubic inches equals 1.95 cubic feet – \$97.66

A \$250 minimum wrapping, packing, loading, unloading, delivery/shipping, customs fees and documentation fee will be charged for all furniture items smaller than 100 cubic feet. All furniture items larger than 100 cubic feet will be charged at a \$2.50 per cubic foot rate.

50 x 50 x 50 = 125,000 cubic inches equals 72.33 cubic feet - \$250
75 x 75 x 75 = 421,875 cubic inches equals 244.14 cubic feet – \$610.35

Any client who purchases items at a price that does not include delivery to our warehouse will be charged whatever additional delivery charges are incurred in the delivery to our warehouse for packing and loading. If the client purchases an item that requires extra packing including but not limited to crating, the client will be charged the additional costs. _____ **Please initial**

Grand Central Station Antiques reserves the right to refuse any item(s) deemed inappropriate for shipment due to but not limited by the following criteria:

1. Not antique furniture or accessories.
2. Item(s) requires extraordinary handling requirements.

The client hereby acknowledges they have been informed and understand that all items purchased are not shipped insured for damage or loss and agree to hold GCSA, its employees, wrappers, packers, and delivery personnel not responsible for any damage incurred for any reason including but not limited to pick up, delivery, wrapping, packing, loading, shipping and unloading. _____ **Please initial**

Grand Central Station Antiques will arrange for meeting the client at the Brussels or Amsterdam airport for transporting to the hotel of their choice as long as the hotel is within 30 minute driving time of Achel. GCSA will provide transportation to either airport at the conclusion of the tour.

The tour will last 3-5 days, depending on what is agreed upon prior to departure. The tour will include dealers determined appropriate by GCSA.

The client will be responsible for retrieval of all items purchased within 7 days of their arrival in San Francisco. A \$25 a week storage/handling fee will be charged on each item not picked up within the 7 day period allowed.

GCSA will provide daily itineraries the night before. Each client will be responsible for being ready at the appointed time and place on each day of the tour. Non-compliance is at the client's discretion.

GCSA will invoice the client while in Europe on the last buying day. Payment is due upon receipt, cash, check, or debit/credit card.
